# TAX TIDBITS

If a taxpayer claims an exemption for a dependent who is at least two years old by December 31, 1990, the taxpayer <u>must</u> list the dependent's social security number (SSN) on Form 1040 or Form 1040A. If the dependent's SSN is not listed or is incorrect, a \$5 penalty may be assessed for each missing or incorrect number.

The SSN requirement changes next year. Dependents who are at least ONE year year old by December 31, 1991 will need social security numbers.

# DECEMBER BOARD MEETING MINUTES


