
#### PRESIDENT'S MESSAGE

## ASWA SPRING CONFERENCE Anchorage, Alaska

(Editor's Note: The following is contributed by Beverly Wandling, sole attendee from the Ames Chapter to the last scheduled Spring Conference of ASWA.)

Fun in the sun and there was a lot of it in this last frontier - from 4:00 in the morning until 11:30 at night in May. The sun shone everyday for the five days I was in Anchorage and the temperature hovered around 70 degrees. I took a suitcase full of cold weather clothes.

The state is huge, so I saw only a tiny part. Traveled inland by bus to Valdez (of oil spill fame) and across the glacier ice fields in a nine-hour boat trip. Rented a car and drove to the port of Seward where the cruise ships dock and depart. Visited a musk ox farm where their wool is harvested for scarves and hats woven by Alaskan natives only. Visited a tiny Russian Orthodox Church and burial ground with colorful "burial houses" built above the grave sites to be inhabited by the departed souls. Rushed through a really wonderful historical exhibit at the Anchorage Museum. I'll return again to spend more time there. I had dinner at Alaska's only five star restaurant, "The Double Muskey Inn," located on a dirt road 35 miles outside of Anchorage. Wonderful food in an Old West atmosphere.

As an after thought, I earned 16 hours of CPE by attending such diverse sessions as "Gaining the Ethics Edge," "Executive Compensation," "Planning Transition in Family-Owned Businesses," and "Office Politics." The absolute best was the young woman whose topic was "Personal Growth through Wilderness Experience." She proved that age or lack of an athlete's body are not barriers to outdoor experiences in a non-threatening group situation. Our speakers, with only an occasional exception, were entertaining and knowledgeable. Missed Fun Night because of the flu, but still had opportunities to meet people and made a new friend, Susan, from California.

And, by the way, I actually saw a moose walking down 7th Avenue in Anchorage. It might even have been the same one that strolls the streets in "Northern Exposure"!

These conferences - the Joint Annual Meeting of AWSCPA-ASWA or "JAM" and ASWA Spring Conference, are special opportunities to see new places, make new friends, earn CPE credits, and grow professionally. Make plans to go ASAP.

Bulletin: Mail Bulletins 1 - 1 1/2 weeks before meeting


Hospitality: Greeting members, table questions, numbered seating, meeting place
