

AMENDMENTS TO BYLAWS

Our Board proposes the following changes to our Bylaws. Several of these are to conform to National's Bylaws and will be so indicated. These Bylaws changes will be voted on at the October Membership Meeting.

PROPOSED: (Conform to National)

Article III, Section 1 (MEMBERSHIP). Prospective members shall be endorsed by a member in good standing

CURRENT:

Article III, Section 1 (MEMBERSHIP). Prospective members shall be endorsed by two members in good standing . . .

PROPOSED: (Conform to National)

Article III, Section 1, Paragraph E (3) (MEMBERSHIP). Retired members shall retain the privileges or rights of the Society as regular or associate members, respectively.

CURRENT:

Article III, Section 1, Paragraph E (3) (MEMBERSHIP). Retired members shall have all the privileges and rights of the Chapter except that they shall not hold elective office.

PROPOSED:

Article XI, Section 1 (DUES). (Add the following sentence at the end of the paragraph.) Annual dues for retired members shall be \$5.00 per year, plus the amount of membership dues payable to the national organization.

CURRENT:

Article XI, Section 1 (DUES). (No reference to retired members in this section.)

REPLACE "Chairman" with "Chair(s)" in each of the following bylaws:

Article VII, Section 4 (BOARD OF DIRECTORS). Each member of the Board of Directors shall serve as chair of such standing committees as may be assigned by the President and approved by the Board of Directors.

Article VIII, Section 2, Paragraph A (COMMITTEES). The Chairs of these committees shall be appointed by the President and approved by the Board of Directors.

Article VIII, Section 2, Paragraph B (COMMITTEES). Members of the committees shall be selected by the respective Chairs with the approval of the President.

Article IX, Section 2 (NOMINATIONS AND ELECTIONS). The Chair of this committee shall be appointed by the Board of Directors.

Article XIV, Section 2 (AMENDMENTS). All amendments adopted by this Chapter shall be submitted to the National Bylaws Chair for approval before becoming effective.

NATIONAL BYLAWS CHANGES

Two amendments to ASWA's National Bylaws will be considered by delegates to the Annual Meeting in Newport Beach, California, October 16, 1992. The National Board of Directors is proposing the two amendments.

Proposed Amendment #1

Amend Article IV - Chapters, Section 1 by striking "Twenty" and inserting in its place "Thirty." Thus the proposed wording would be "Thirty or more prospective members, eligible for regular membership, may petition the Society for a charter."

Proposed Amendment #2

Amend Article XII - Dues, Section 2 by strking "June 30" and inserting in its place "June 1." Thus the proposed wording would be "Dues shall become payable on July 1, based on the membership status as of June 1, and shall become delinquent 60 days after the invoice date but not earlier than September 1. Any member whose dues have not been paid within this time shall be dropped from membership. Reinstatement within the fiscal year may be granted upon payment of \$5 and the full year's dues by June 1 of that fiscal year."

Our delegate to the ASWA Annual Meeting is Beverly Wandling. The Chapter needs to give Beverly instructions on how to vote on these two amendments (either specifically or in general), but she needs to know how we, the members, feel about the issues. Please think about these two issues and bring your thoughts to the October Membership Meeting.

A discussion was held as to whether we should change the date to accommodate the speaker at another time, but it was decided to keep the meeting on our regular night and try to get another speaker. Members will meet at 5:00 p.m. in the Ames Savings parking lot on Tuesday, September 15, 1992 to car pool to the Joint Meeting with the Des Moines Chapter being held in Ankeny.

ANNOUNCEMENTS: Kate Mulder announced that the new supply order forms from National have some new items on them. Ordering will be done at the end of the month. The next board meeting is October 8, 1992, 5:00 p.m. at Aunt Maude's.

ADJOURNMENT: On motion made by Stephanie Fox, seconded by Josie Niemand, motion carried that the meeting be adjourned at 12:30 p.m.



SYMPOSIUM PLANNED

The Des Moines Chapter of ASWA, in conjunction with the Iowa Society of CPAs, the Institute of Management Accountants, A.P.I.C.S. and Robert Half and Accountemps will be co-sponsoring the THIRD ANNUAL PROFESSIONAL DEVELOPMENT SYMPOSIUM on October 21, 1992, at the Crystal Inn and Conference Center (formerly the Airport Hilton Inn).

The symposium this year will offer participants a choice of 4 hours or 8 hours of CPE. Participants can select from three program tracks in the morning and three tracks in the afternoon.

Registration fees for the program are: \$75 for 8 hours CPE (lunch included) and \$50 for 4 hours CPE (lunch included). A \$15 late fee will be charged on registrations received within 10 working days of the symposium. A separate mailing will be sent to members in the near future.

The Des Moines Chapter has asked that any members or others we know attending to please mark that they heard about the symposium through ASWA. The profits from the symposium are split between the groups based on the number of people checking each organization. The Des Moines Chapter is using their share of the profits in their scholarships. Let's help them out if we can.

RESOLUTION TO TERMINATE AWSCPA IS DEFEATED

A special meeting of the members of AWSCPA was held on August 1, 1992 to discuss and vote on a resolution to terminate AWSCPA upon the assumption of comparable activities by the AICPA with the anticipation that the net assets of AWSCPA be utilized to provide services for the members of AWSCPA until the AICPA assumes responsibility for providing such services. The motion was defeated with 479 voting for and 1,190 voting against the resolution. (Per AWSCPA Summer 1992 National Newsletter)

Budget Assumptions for FY 1993 Budget

Revenue Assumptions:

- 1. 30 regular members and 5 student members.
- 2. Additional miscellaneous income will come from small extra charges for regular meeting meals. Estimated \$1/member X 15 members X 7 meeting meals meals = \$105, which was rounded to \$100.

Expenditure Assumptions:

- 1. Program/speaker 7 speakers will be needed.
- 2. Bulletin expenditures will be low assuming private companies contribute to the cost. This will also include postage.
- 3. Education program will be self-supporting.
- 4. ASWA lapel pins will be given to new members: est. 6 pins X \$10/ea. = \$60.

SPONSORS STILL NEEDED


