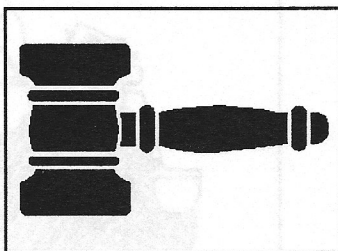
PRESIDENT'S MESSAGE

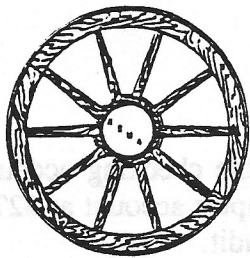
Jodi-Adams Hein graduated from ISU this past December with a major in Accounting. Congratulations to you, too, Jodi.
