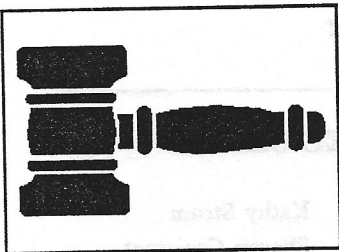

Board of Directors Meeting
May 11, 1993

CALL TO ORDER: The regular monthly meeting of the Board of Directors, Ames Chapter, was brought to order at approximately 11:55 a.m. on Tuesday, May 11, 1993, at Country Kitchen Restaurant, Ames, Iowa, President Kathleen Strum presiding.

QUORUM: A quorum was present.

ATTENDANCE: The following Board members were in attendance: Kathy Strum, Karen Jacobson, Kate Mulder, Nancy Campbell and Beverly Wandling. In addition, President-Elect Kim Supercynski was in attendance.

BUSINESS:

Minutes: On motion made by Kate Mulder, seconded by Karen Jacobson, motion carried unanimously that Board minutes for the March 18 and April 8 meetings be approved as presented in the Bulletin. On motion made by Karen Jacobson, seconded by Kate Mulder, motion carried unanimously that the Board minutes for February 25 be amended to remove the name "Nancy Campbell" as being elected by the Board to serve on the Nominating Committee. Nancy was elected by the membership, not the Board.

Treasurer's Report: At the end of April 1993, there was \$288.49 in the checking account and \$450.40 in the savings account. Donations for Student Night totaled \$120 to date. The report was placed on file for audit.

Board Appointment: It was recommended that Judy Farthing be appointed to fill the remaining term as director (Membership Chair) due to the fact that the Board is now short two members as a result of resignation/moving. On motion made by Nancy Campbell, seconded by Karen Jacobson, motion carried unanimously that Judy Farthing be so appointed.

Administrative Reporting: No report.

Bulletin: The Bulletin deadline is May 21st and the final sponsor for this fiscal year has been obtained. President-Elect Kim Supercynski noted that the new Bulletin chair has resigned from the Chapter. It was decided that the membership would be asked for a volunteer. The Board discussed the continuing need to find sponsors and other alternatives to paying for the bulletin. It was suggested that the mailing list be kept as small as possible to facilitate finding sponsors. In addition, a quarterly publication was suggested. This solution would not solve the problem as monthly meeting information and minutes would still need to be mailed out.

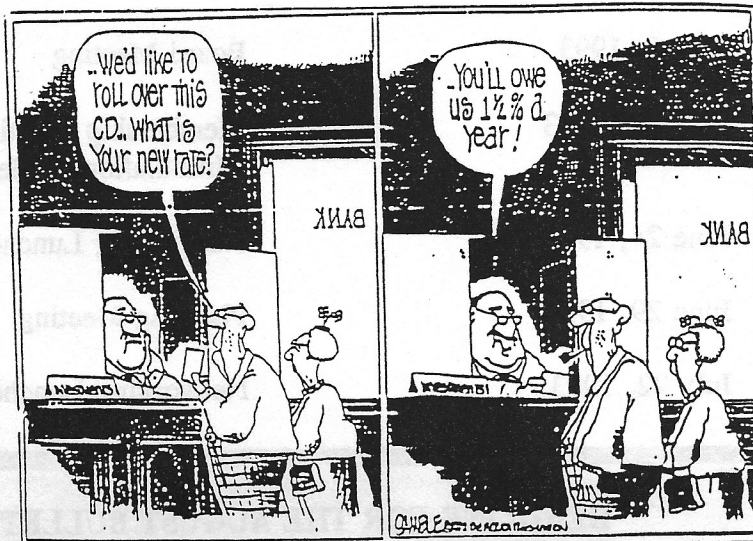

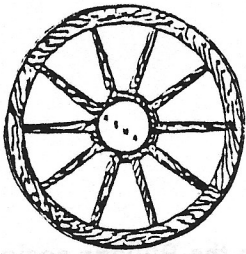
