November 11, 1993

CALL TO ORDER: The November meeting of the Ames Chapter No. 158 of the American Society of Women Accountants was called to order at approximately 6:12 p.m. on November 11, 1993 at Aunt Maude's Restaurant in Ames, President Kim Supercynski presiding.

QUORUM: A quorum was present.

ATTENDANCE: There were 11 members, one guest and the speaker in attendance.

RECOGNITION OF PAST PRESIDENT: President Kim Supercynski presented Immediate Past President Kathy Strum with a thank you gift for her service as President of the Ames Chapter during the 1992-1993 year.

BUSINESS:

Minutes: On motion made by Jan Duffy, seconded by Kathy Strum, motion carried unanimously that the minutes for the September 10, 1993 meeting be approved as printed in the Bulletin.

Treasurer's Report: At the end of October there was \$547.70 in the checking account and \$693.97 in the savings account. Fifteen members have renewed and there is one new member. The report will be placed on file for audit. The review for the fiscal year 1992-1993 has been received and forwarded on to National.

Committee Reports:

Administrative Reporting: No report.

Bulletin: The deadline for the January Bulletin is December 27, 1993. There will be no Bulletin in December.

Education and Legislation: No report.

NEW BUSINESS: The National Scholarship applications have been received and Jan Duffy will pursue this at ISU. Kim reported on the JAM in Minneapolis which six members attended. Treasurer Kate Mulder discussed the dues increase. Some of the ideas at the Chapter Exchange were also discussed.

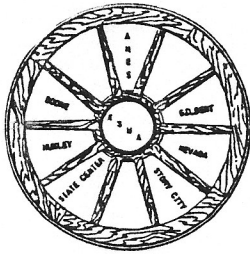
ANNOUNCEMENTS: November and December Meals on Wheels volunteers were announced.
