QUORUM: A quorum was present.

ATTENDANCE: The following Board members were in attendance: Kathy Strum, Kate Mulder, Judy Farthing, Karen Jacobson, and Kim Supercynski.

BUSINESS:

Minutes: There were no minutes because there was no quorum at the December meeting and no official business was conducted.

Treasurer's Report: At the end of December 31, 1993, there was \$651.71 in the checking account and \$916.11 in the savings account. The only outstanding bills are one member's dues to National and the second half of last year's scholarship. The scholarship fund has such a large balance due to the generous donations of several of our members. The report was placed on file for audit.

OLD BUSINESS: Another T-shirt order was discussed and it was decided to only order the CPA design in XL and XXL sizes. Margaret Haubrich will be notified and she will contact Beverly Wandling who handled the original order. The meeting with the ISU Accounting Club was discussed and the Board felt it was necessary to take the students out for pizza afterwards like we did last year. Additional donations from members not attending would be greatly appreciated to help defray the cost. Jan Duffy will make the arrangements. NEW BUSINESS: Kim Supercynski announced that the IPTV Telethon will be held in March and we have been scheduled to work on Saturday, March 12th from 10:15 a.m. to 12:30 p.m. We need 10 volunteers for our shift. Potential new members include Laurie Gustafson from ISU and Annette Kane.

Nominating Committee: On motion made by Kate Mulder, seconded by Judy Farthing, motion carried that Karen Jacobson be the Board's representative on the Nominating Committee.

<u>Scholarship</u>: The Chapter scholarship applications need to get out to the students soon. Kate Mulder will visit with Margaret Haubrich about this.


Teach me the glorious lesson that occasionally it is possible that I may be mistaken.
