QUORUM: A quorum was present.

ATTENDANCE: The following Board members were in attendance: Kate Mulder, Karen Jacobson, Nancy Campbell and Kim Supercynski.

BUSINESS:

Minutes: On motion made by Nancy Campbell, seconded by Kate Mulder, motion carried unanimously that the minutes of the January 13, 1994, Board Meeting be approved as printed in the Bulletin.

Treasurer's Report: At the end of January 31, 1994, there was \$593.59 in the checking account and \$766.11 in the savings account. The report was placed on file for audit.

OLD BUSINESS: Kim Supercynski announced that we still need 2 volunteers for our 10-person shift at the IPTV Telethon on Saturday, March 12th from 11:00 a.m. to 1:15 p.m. There was no Nominating Committee report because the election by the membership had not taken place yet. 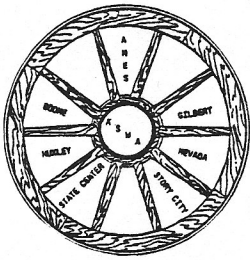
