**NEW BUSINESS:**

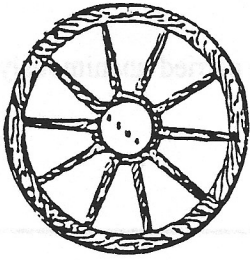
