

CALL TO ORDER: The regular monthly meeting of the Board of Directors, Ames Chapter, was brought to order at approximately 5:35 p.m. on Thursday, September 8, 1994 at the Broiler, Ames, Iowa, President Nancy Campbell presiding. QUORUM: A quorum was present.

ATTENDANCE: The following people were in attendance: Nancy Campbell, Kate Mulder, Jan Duffy, Kim Supercynski, Margaret Munson, Karen Jacobson, Brenda O'Neall-Smith, and Cindy Sippel. **BUSINESS:**

Minutes: Kate Mulder noted that the minutes of the August 11 Board Meeting as printed in the Bulletin contained an error. The business card holders have not been ordered yet. The minutes will be corrected to state that the business cards will be ordered. On a motion made by Cindy Sippel, seconded by Kate Mulder, motion carried unanimously that the minutes of the August 11, 1994 Board Meeting be approved as amended.
