MEETING INFORMATION

Topic: Automating the Financial Close Financial close is a recurring process with known input sources and pre-defined outputs. While most recurring processes have deployed technology to achieve efficiency, quality, repeatability, and uniformity, many companies still rely on a highly manual, time consuming process to perform financial close tasks. The financial close process has recently received attention from CPAs and regulators due to the uncertain economy, the increase in restatements, and recent financial reporting changes such as mandating the use of XBRL format and new fair value accounting standards. To address these concerns, we have examined the financial close process in 15 companies of various sizes. This session will present our study results.
