Minutes:

Jamie Williamson moved and Margaret Munson seconded a motion to approve the November minutes. The motion passed.

Treasurer's Report: Treasurer's Reports for November, December and January were distributed. The general account has a balance of \$7,827.09 and the scholarship account has a balance of \$4,420.61. Letters have been sent to the membership detailing their contributions to the scholarship for 2013. Members are also reminded to see if their companies have matching gift programs. The reports will be placed on file for review.

The new management company will be Associations International (AI) and is expected to offer our organization more office support. The goal is to make the change as seamless as possible.
