#### About our Presenter: Mike Upah

Mike Upah serves as CFO at iSEEK Corporation, an Ames software company that provides engineering software to companies such as John Deere, Kohler and Peterbilt. In that role he directs fundraising and accounting operations, and is also involved in business development projects.

iSEEK Corporation was a startup company that Upah assisted when he was directing the business development activities of the Iowa State University Pappajohn Center for Entrepreneurship, a program closely affiliated with the Iowa State University Research Park. In that role, Upah worked with dozens of startup technologies companies and hundreds of community businesses in broad areas ranging from information technology to human drug development and provided guidance to companies in the areas of market assessment, intellectual property, licensing, business plan development, private equity fundraising, and business operations.

Previous to joining the Pappajohn Center Mike was involved in two separate entrepreneurial activities. Mike was a founding partner of RCI Environmental Consulting Services in Dallas, Texas, and thereafter he joined Kreg Tool Company of Huxley, Iowa, where he served as Director of Marketing, Product Development and Controller. Mike is an alum of Iowa State University and currently serves on the boards of iSEEK Corporation, Harrisvaccines, FloMetrix, Innovative Energy Solutions, the Huxley Development Corporation and the Ballard Foundation Committee.

- C. Bulletin: Members are encouraged to meet the deadlines for the bulletin.
