Cyndie is the past editor of research on professional responsibility and ethics in accounting. She is a member of the AICPA, Accounting and Financial Women's Alliance, and the American Accounting Association, and she was the founding director of the Master of Accounting program at Iowa State University. Cyndie received her Ph.D. from the University of Minnesota and has completed the IFRS Certificate of Educational Achievement.

#### **New Business:**

National Bylaw Amendments: Kate

reviewed the three bylaw amendments. 1 – Dues will be changed back to all at June 30, rather than on the member's anniversary date. This recommendation to change was done because of comments from chapters on the difficulty of monitoring membership every month. Karen mentioned that concerns were expressed at the Bylaws Forum at the recent national conference in Orlando regarding proration for new members and those not currently on a June 30 renewal date. The issue was satisfactorily addressed at that time. 2 – This amendment is to clarify networks and that they are not operating as a chapter. 3 – This amendment is to clarify the pathway to leadership at the national level for members-at-large. There was not much discussion on any of these amendments. National will be sending out an e-mail ballot to each individual member as these are no longer voted on by chapters due to a prior change in National's bylaws. Kate mentioned that anyone wishing to comment on these amendments could do so with National President-Elect Tyna Gaylor by December 20, 2019.

**Chapter Standing Rules:** Margaret mentioned that the information regarding the Founder's Day Award was inadvertently omitted from the last update to the Standing Rules for the Chapter. She also noted that it was appropriate to change position of the apostrophe in the word Founders so that it will now be Founders' Day Award. The following will now be included in the Chapter Standing Rules regarding the Founders' Day Award:

The Chapter may award a Founders' Day Award for long-term service to the Chapter. Nominations for the award may be made to the Board by any member. Upon receipt of a nomination, the Board will convene a committee of the Board, not including the nominee, to

consider the nomination and, if the committee approves the nomination, to prepare and present the award.
