Presenter: Dr. Johanna Amaya is an Assistant Professor in the Department of Supply Chain Management at Iowa State University Ivy College of Business. She received her B.Sc. in Industrial Engineering from Universidad del Norte, Colombia. She got a M.Sc. in Industrial and Systems Engineering, from University of Florida and completed her PhD. in Transportation Engineering at Rensselaer Polytechnic Institute. She is an expert in disaster response logistics, sustainable urban freight transportation, and supply chain management.

Learning Objectives & Program Content: Disasters pose many challenges to relief and response agencies, and as such, it has become a great opportunity for applied research in logistics and operations. This talk will discuss Disaster Response Logistics (DRL) in connection with the functions conducted by relief agencies, and identifies under-studied areas where research could enhance operational effectiveness. The discussion relays the chief findings of fieldwork research conducted, which supports the development of policies to improve preparation and coordination of disaster response activities.
