#### Minutes

Karen Jacobson noted that the scholarship committee report was omitted from the August minutes published in the bulletin and proposed that the minutes be amended to show that the committee intends move the application to the fall, with a goal of approving awards at the November meeting. The committee will also seek ideas for fundraising. Karen Jacobson moved and Cindy Sippel seconded that the August minutes be approved as amended. Motion carried.
